I/We, therefore, declare that I/We assume all risks incident to the entry and use of said real property and participation in the activities, events and contests sponsored or participated in by the Hawaii Motorsports Association and I/We hereby release, acquit and forever discharge the Hawaii Motorsports Association, the owners and lessee of said property, their officers, agents, employees or representatives and all other sponsoring clubs and their members from any liability, claim demands, action or right of action for death, personal injury or damage to personal property, however caused.
