I hereby acknowledge that my participation in connection with any part of the North Shore Grand Prix V Event is done voluntarily and at my own risk. I acknowledge that Motorcycle racing and related activities are hazardous activities and that I have made a voluntary choice to participate in this activity despite the risk involved accordingly, I hereby represent and agree to the following as a condition of my participation in the North Shore Grand Prix V Event:

I therefore, for myself, my heirs, successors, assigns and representatives hereby KNOWINGLY AND INTENTIONALLY WAIVE AND AGREE TO INDEMNIFY, HOLD HARMLESS, LIST EVERYONE HERE..ALL SPONSORS, their owners, bottlers, subsidiaries, affiliates, agents, employees (hereinafter the sponsor parties) and all board members and affiliates of the Hawaii Motorcycle Association. All members of the North Shore Racing Club, City and county, The state of Hawaii, All sponsors and promoters, administrators, and officials of the event. ("Sponsor") and its affiliates, agents and employees from any and all liability for any and all damage, injury, paralysis, or death to myself or property that I may incur incurs a result of my participation in the North Shore Grand Prix V Event. I explicitly agree that this release and indemnification extends to harm resulting from any negligence of all the mentioned parties or the Sponsors.
